The Higher Level Skills program is a key initiative under the Queensland Government's five (5) year training reform action plan, [Great skills. Real opportunities.](#) The program provides a government subsidy to support eligible individuals to access one subsidised training place in selected Certificate IV level and above qualifications, or priority skill sets.

Please complete this form and provide the applicable evidence so we can determine your eligibility for a Higher Level Skills subsidy and ensure you understand your obligations as a participant when accessing this funding.

Please keep in mind that if you do not meet the eligibility requirements for Higher Level Skills Funding, that does not mean you are not eligible to enroll and complete your course - it simply means you will not be eligible to receive the Higher Level Skills subsidy. A 'Time to Pay' arrangement, or Student FEE-HELP may be available should you be unable to pay for your course upfront.

* Existing Worker - You must be a current employee who has a one (1) month or more employment relationship with their employer and has actively fulfilled work duties for this period. The one (1) month working relationship could be full-time or on a part-time/casual employment equivalent basis. Existing workers have access to employee entitlements and therefore do not include volunteers. Registration with a Labour Hire Company does not satisfy the 'existing worker' requirement, unless at the commencement of the training the prospective student has been engaged in employment for a period of one month or more and is currently employed.

Confirmation of Employment must be a letter/email from the employer (including company logo) stating student name, position held, confirming Employment aligned to the qualification in the relevant industry at the time of enrolment, and employer contact details.
