The Certificate 3 Guarantee is a key initiative under the Queensland Government's five (5) year training reform action plan, [Great skills. Real opportunities.](#) The Certificate 3 Guarantee provides a government subsidy to assist eligible Queenslanders who do not have a post school qualification higher than a Certificate II, to obtain a Certificate III level qualification.

Please complete this form and provide the applicable evidence so we can determine your eligibility for a Certificate 3 Guarantee subsidy and ensure you understand your obligations as a participant when accessing this funding.

Please keep in mind that if you do not meet the eligibility requirements for Certificate 3 Guarantee, that does not mean you are not eligible to enroll and complete your course - it simply means you will not be eligible to receive the Certificate 3 Guarantee subsidy. A 'Time to Pay' arrangement may be available should you be unable to pay for your course upfront.
